Ideally you will have some experience of working with people who present as neurodivergent and an understanding of mental health and it's impact on our target community.

You will support the ongoing development of knowledge, understanding and confidence about Suicide Prevention in Family Action through the development of an evidence based toolkit for dissemination through out our service.

You will have the ability to build effective relationships with people with lived experience and to work collaboratively with them and front line service staff to inform the resource content.
