With some existing knowledge about Suicide Prevention approaches, you will be willing to become an accredited Suicide Prevention trainer (training provider). Ideally you will have some experience of working with people who present as neurodivergent and an understanding of mental health and it's impact on our target community.

We are looking for a Suicide Prevention Trainer to deliver accredited Suicide Prevention training both within Family Action and to local VCSE and grass roots organisation in order to build confidence in managing positive conversations about mental health and suicidial ideation. You will support the ongoing development of knowledge, understanding and confidence about Suicide Prevention in Family Action through the development of an evidence based toolkit for dissemination through out our service.

We are looking for a values based individual with a track record in the delivery of high quality training and the ability to work collaboratively to create evidence based resources appropriate to a range of services and projects. You will have the ability to build effective relationships with people with lived experience and to work collaboratively with them and front line service staff to inform the resource content.
